DATA PROTECTION NOTICE TO EMPLOYEES AND JOB APPLICANTS

This Data Protection Notice ("Notice") sets out the basis upon which FAITH CORPORATION PTE LTD ("FC", "us" or "our") may collect, use, disclose or process personal data of employees and job applicants in accordance with the Personal Data Protection Act ("PDPA"). This Notice applies to personal data in our possession or under our control, including personal data in the possession of organisations which we have engaged to collect, use, disclose or process personal data for our purposes.

APPLICATION OF THIS NOTICE

1. This notice applies to all persons engaged in a contract of service with us (whether on a part-time, temporary or full-time basis) and interns and trainees working at or attached to us (collectively referred to as "**employees**") as well as persons who have applied for any such position with us ("**job applicants**") and all references to "employment" shall apply equally to internships and traineeships (as may be applicable).

PERSONAL DATA

2. As used in this notice, "**personal data**" means data, whether true or not, about an employee or job applicant who can be identified (a) from that data; or (b) from that data and other information to which we have or are likely to have access.
3. ***If you are a job applicant***, personal data which we may collect includes, without limitation, your:
 - name or alias, gender, date of birth, nationality and citizenship;
 - mailing address, telephone number, email address and other contact details;
 - resume, educational qualifications, professional qualifications and certifications and
 - employment and training history;
 - work-related health issues and disabilities; and
4. ***If you are an employee***, personal data which we may collect in the context of your employment with us includes, without limitation, your:
 - name or alias, gender, NRIC/FIN or passport number, date of birth, nationality and citizenship;
 - mailing address, telephone number, email address and other contact details;
 - employment and training history;
 - salary information and bank account details;
 - details of your next-of-kin, spouse and other family members;
 - work-related health issues and disabilities;
 - records on leave of absence from work;
 - photographs and other audio-visual recordings;
 - performance assessments and disciplinary records; and
 - any additional information provided to us by you as a job applicant (that is, prior to being engaged as an employee)
5. Other terms used in this Notice shall have the meanings given to them in the PDPA (where the context so permits).

COLLECTION, USE AND DISCLOSURE OF PERSONAL DATA

6. We generally collect personal data that (a) you knowingly and voluntarily provide in the course of or in connection with your employment or job application with us, or via a third party who has been duly authorised by you to disclose your personal data to us (your "authorised representative", which may include your job placement agent), after (i) you (or your authorised representative) have been notified of the purposes for which the data is collected, and (ii) you (or your authorised representative) have provided written consent to the collection and usage of your personal data for those purposes, or (b) collection and use of personal data without consent is permitted or required by the PDPA or other laws. We shall seek your consent before collecting any additional personal data and before using your personal data for a purpose which has not been notified to you (except where permitted or authorised by law).

Choice of Collection

7. You have the right to choose whether to provide your personal data to FAITH CORPORATION PTE LTD. However, without the necessary information, we may not be able to process your job application or continue your employment, or provide certain related benefits. Consent for the collection, use, and disclosure of personal data will be sought before processing, unless an exception applies under the Personal Data Protection Act (PDPA).

Exceptions to Consent Requirement

8. In specific situations permitted by the PDPA or other applicable laws, we may collect, use, or disclose your personal data without your consent, such as:
 - Emergencies threatening the life, health, or safety of any individual.
 - Situations where it is necessary in the national interest.
 - For any investigation or legal proceedings.
9. ***If you are a job applicant***, your personal data will be collected and used by us for the following purposes and we may disclose your personal data to third parties where necessary for the following purposes:
 - assessing and evaluating your suitability for employment in any current or prospective position within the organisation;
 - verifying your identity and the accuracy of your personal details and other information provided;
10. ***If you are an employee***, your personal data will be collected and used by us for the following purposes and we may disclose your personal data to third parties where necessary for the following purposes:
 - performing obligations under or in connection with your contract of employment with us, including payment of remuneration and tax;
 - all administrative and human resources related matters within our organisation, including administering payroll, granting access to our premises and computer systems, processing leave applications, administering your insurance and other benefits, processing your claims and expenses, investigating any acts or defaults (or suspected acts or defaults) and developing human resource policies;
 - managing and terminating our employment relationship with you, including monitoring your internet access and your use of our intranet email to investigate potential contraventions of our internal or external compliance regulations, and resolving any employment related grievances;
 - assessing and evaluating your suitability for employment / appointment or continued employment / appointment in any position within our organization;
 - ensuring business continuity for our organization in the event that your employment with us is or will be terminated;
 - performing obligations under or in connection with the provision of our goods or services to our clients.
 - facilitating any proposed or confirmed merger, acquisition or business asset transaction involving any part of our organisation, or corporate restructuring process; and
 - facilitating our compliance with any laws, customs and regulations which may be applicable to us; and
 - submission of relevant data to government agencies for security, regulatory, or compliance purposes
11. The purposes listed in the above clauses may continue to apply even in situations where your relationship with us (for example, pursuant to a contract) has been terminated or altered in any way, for a reasonable period thereafter (including, where applicable, a period to enable us to enforce our rights under any contract with you).
12. After the lapse of the opt-out period, you may notify us that you no longer wish to consent to the purposes for which your consent was deemed by notification by withdrawing your consent for the collection, use or disclosure of your personal data in relation to those purposes.

WITHDRAWING YOUR CONSENT

13. The consent that you provide for the collection, use and disclosure of your personal data will remain valid until such time it is being withdrawn by you in writing. You may withdraw consent and request us to stop collecting, using and/or disclosing your personal data by submitting your request in writing or via email to our Human Resources Department at the contact details provided below.
14. Upon receipt of your written request to withdraw your consent, we may require reasonable time (depending on the complexity of the request and its impact on our relationship with you) for your request to be processed and for us to notify you of the consequences of us acceding to the same, including any legal consequences which may affect your rights and liabilities to us. In general, we shall seek to process your request within ten (10) business days of receiving it.
15. Whilst we respect your decision to withdraw your consent, please note that depending on the nature and extent of your request, we may not be in a position to process your job application (as the case may be). We shall, in such circumstances, notify you before completing the processing of your request (as outlined above). Should you decide to cancel your withdrawal of consent, please inform us in writing in the manner described in clause 13 above

16. **If you are a job applicant:** Withdrawing your consent may affect our ability to continue processing your job application. Where this is the case, we will inform you in advance of the likely consequences before completing your withdrawal request.
17. **If you are an employee:** Withdrawing consent may affect our ability to maintain your employment or provide certain benefits. We will inform you in advance of the likely consequences.
18. Please note that withdrawing consent does not affect our right to continue to collect, use and disclose personal data where such collection, use and disclose without consent is permitted or required under applicable laws.

ACCESS TO AND CORRECTION OF PERSONAL DATA

19. If you wish to make (a) an access request for access to a copy of the personal data which we hold about you or information about the ways in which we use or disclose your personal data, or (b) a correction request to correct or update any of your personal data which we hold, you may submit your request in writing or via email to our Human Resources Department at the contact details provided below.
20. Please note that a reasonable fee may be charged for an access request. If so, we will inform you of the fee before processing your request.
21. We will respond to your request as soon as reasonably possible. In general, our response will be within ten (10) business days. Should we not be able to respond to your access request within thirty (30) days after receiving your access request, we will inform you in writing within thirty (30) days of the time by which we will be able to respond to your request. If we are unable to provide you with any personal data or to make a correction requested by you, we shall generally inform you of the reasons why we are unable to do so (except where we are not required to do so under the PDPA).
22. Please note that depending on the request that is being made, we will only need to provide you with access to the personal data contained in the documents requested, and not to the entire documents themselves. In those cases, it may be appropriate for us to simply provide you with confirmation of the personal data that our organisation has on record, if the record of your personal data forms a negligible part of the document.

PROTECTION OF PERSONAL DATA

23. To safeguard your personal data from unauthorised access, collection, use, disclosure, copying, modification, disposal or similar risks, we have introduced appropriate administrative, physical and technical measures such as minimised collection of personal data, authentication and access controls (such as good password practices, need-to-basis for data disclosure, etc.), encryption of data, data anonymisation, up-to-date antivirus protection, regular patching of operating system and other software, securely erase storage media in devices before disposal, web security measures against risks and security review and testing performed regularly
24. You should be aware, however, that no method of transmission over the Internet or method of electronic storage is completely secure. While security cannot be guaranteed, we strive to protect the security of your information and are constantly reviewing and enhancing our information security measures.

ACCURACY OF PERSONAL DATA

25. We generally rely on personal data provided by you (or your authorised representative). In order to ensure that your personal data is current, complete and accurate, please promptly notify us of any changes to your personal data by informing our Human Resources Department or Data Protection Officer in writing or via email at the contact details provided below.
26. **If you are a job applicant:** You are responsible for ensuring that all personal data you provide is accurate and complete, including but not limited to your NRIC/FIN, academic and professional qualifications, and employment history. False or misleading information may result in the withdrawal of any employment offer or termination of your application.

27. ***If you are an employee:*** You must promptly notify Human Resource Department or the Data Protection Officer if your personal data changes, and provide accurate and complete information at all times. This includes, but is not limited to, your NRIC/FIN, residential address, contact number, emergency contact details, and bank account information for payroll purposes.

RETENTION OF PERSONAL DATA

28. We may retain your personal data for as long as it is necessary to fulfil the purposes for which they were collected, or as required or permitted by applicable laws.
29. We will cease to retain your personal data, or remove the means by which the data can be associated with you, as soon as it is reasonable to assume that such retention no longer serves the purposes for which the personal data were collected, and are no longer necessary for legal or business purposes.

TRANSFERS OF PERSONAL DATA OUTSIDE OF SINGAPORE

30. We generally do not transfer your personal data to countries outside of Singapore. However, if we do so, we will obtain your consent for the transfer to be made and will take steps to ensure that your personal data continues to receive a standard of protection that is at least comparable to that provided under the PDPA.
